RDAP Feature Article

Recap of the Medical Library Association 2021 conference

The Medical Library Association (MLA) held MLA '21 virtually this past May, with a theme of "Transforming our Diversifying Communities". Presentations, panels, and posters spoke to the need to diversify not only the library workforce, but also our teaching methods and skill sets. Here is a sample of the fantastic work related to research and data literacy discussed at the conference.

Peace Ossom-Williams (University of Texas-Arlington), Laura Haygood (University of North Texas), and Hammad Khan (UT-Arlington) presented their work developing the Data Analytics Research Training (DART) Fellowship, targeted towards health librarians working with underrepresented groups in the South Central United States. This experiential learning course was designed to be a mix of in-person and virtual learning, but like so much else, it had to pivot due to COVID-19. The Fellowship was reworked as a self-paced online course, and the majority of the first 24 participants (75%) agreed or strongly agreed that the format worked well and that they improved their data literacy skills. Future work is needed to measure whether learning is as robust in the fully virtual setting.

Three presentations focused on research reproducibility and the role of the data librarian. Lisa Federer (National Library of Medicine) discussed the use of Common Data Elements at the NIH and NLM in order to make sure data is consistent and reusable across studies. Nina Exner (Virginia Commonwealth University) described a course on the importance of research reproducibility designed for MD/PhD students. The course covered a variety of topics, from experimental design to data reporting, all with an eye towards reproducibility. Finally, Peter Oxley and Terrie Wheeler (Weill Cornell Medical School) explained how their library promotes data retention and management through the use of a data catalog. This catalog covers research projects from initial funding to completion and allows for data to be linked to articles and grants, providing easier data governance.

Because the MLA encompasses a wide variety of libraries, from hospitals to research universities to the National Library of Medicine, the conference is a wonderful way to learn about various approaches to research and data management. I, for one, plan to "borrow" many of the new ideas presented for my own library!
