## RDAP Feature Article

This fiscal year, RDAP Executive Board members led the RDAP community in responding to two requests for information (RFIs) from federal executive agencies. We responded to NIH's [RFI on Developing Consent Language for Future Use of Data and Biospecimens](#) and the Office of Science and Technology Policy (OSTP) [RFI to Improve Federal Scientific Integrity Policies](#).

The NIH RFI concerned the development of consent language supporting the

sharing and future use of data and biospecimens in an ethical and secure manner. The sample language is considered a resource for researchers, is voluntary, and does not supplant existing requirements that support informed consent. This language clarifies the storage practices for biospecimens as well as the control mechanisms to ensure privacy in the event that the data is used by other investigators. In [addressing the RFI from NIH](#), RDAP praised the development of the consent language, but encouraged the addition of clarification on repository options and access to physical specimens. RDAP commenters also emphasized the usefulness of sample language that allows open access to data in addition to controlled access.

As a response to the January 27, 2021 [presidential memorandum](#) entitled “Memorandum on Restoring Trust in Government Through Scientific Integrity and Evidence-Based Policymaking”, OSTP was directed to convene an interagency task force to review the effectiveness of federal policies created since 2009, as well as the best practices and policies that could be adopted by federal agencies to support scientific integrity. A call for information was released in June 2021. In its [response to the RFI from OSTP](#), RDAP emphasized that “appropriate and effective research data management and sharing is an important foundational step for ensuring transparency and integrity in science and scholarship.”

OSTP thanked RDAP for its response in January when publishing its report, [Protecting the Integrity of Government Science](#). In the [press release](#), OSTP noted, “Supporting scientific integrity requires attention to other policy areas, including greater transparency into research processes and outputs” and guidelines for data. It is great to see the work of research information professionals like those in the RDAP community being valued at the highest levels of the US research enterprise!

The Research Data Access and Preservation Association (RDAP) and the *Journal of eScience Librarianship (JeSLIB)*, pleased to continue their partnership for a fifth year, announce the forthcoming Special Issue published by *JeSLIB* for the 2022 RDAP Summit. The 2022 Special Issue will focus on the Summit's theme, Envisioning an Inclusive Data Future. In order to promote diversity and inclusion, we encourage submissions from presenters who focus on DEI-related topics or identify as a member of an underrepresented group. Full-length and e-Science in Action papers are subject to double-blind peer review, while commentaries will be reviewed by the guest editors and editor-in-chief.

Manuscript submissions are due July 1, 2022 for publication in the November 2022 special issue. Mentorship is available to support submissions.
